Submission Guidelines

1. All abstracts must be submitted in English;
2. The manuscript must follow the following formatting rules:
 - Title: Times New Roman, size 16, centered alignment;
 - Authors: Times New Roman, size 14, centered alignment;
 - Body and Authors Affiliation: Times New Roman, size 12, justified alignment and a maximum of 350 words;
 - Document margins: top and bottom - 2,5cm, left and right - 3,0cm.
3. The presentation preference must be specified at the bottom of the document. The “Oral” option (in English or Portuguese), while the “Poster” option allows the submitter to present a poster, from the abstract submitted, at the poster exhibition.
4. The submissions must be done via email to lsouto@ua.pt
5. The submission must include the pdf and Word (or equivalent) files.

Margins: top - 17cm; standing - 5cm; sides - 2,5cm Text: English and / or Portuguese

Title: Helvetica, bold, 80 pt, left alignment, black color

Subtitle: Helvetica, 80 pt, left alignment, black color

Name of the author (s): Helvetica, font size 35pt, color black

Department name / research unit: Helvetica, font size 35pt, color black

Core titles: Helvetica, bold, 28pt font size, left-aligned text, black color

Plain text: Helvetica, regular, 28pt font size, left-aligned text, black color

Printing: A0-size posters
